#### *Debbie Goff PharmD, FCCP*

Dr. Goff is an Infectious Diseases clinical pharmacist with over 30 years of experience providing patient care & research at The Ohio State University (OSU) Wexner Medical Center and Professor of Pharmacy Practice in the College of Pharmacy in Columbus, Ohio. She is an award winning global “change maker” in infectious diseases. Her global impact extends across 36 countries. She is one of twenty-five global health experts selected by the World Health Organization (WHO) to implement antibiotic stewardship programs in low middle-income countries.

In 2018, Dr. Goff collaborated with a prosthodontist (her husband) to conduct a workshop with private practice dentists, orthopedic surgeons and OSU lawyers to examine the use of dental antibiotic prophylaxis in joint implant patients and risk of lawsuits. Dr. Goff published the first US study with private practice dentists to evaluate dental antibiotic use and provide guidance on the use of antibiotics in dentistry. Dr. Goff is an invited speaker for dental study clubs, state dental society conferences & international dental conferences. Over 3,800 dentists have attended her lectures and antibiotic workshops. Her TEDx talk “Antibiotics: just-in-case” has over 35,000 views on YouTube. She has over 150 publications, numerous grants and lectures nationally and internationally.
